DGB ASIA BERHAD ("DGB" (0152)) SHARE CONSOLIDATION

Participating Organisations are to take note of the following Share Consolidation exercise by **DGB ASIA BERHAD**.

The Share Consolidation comprises the following:-

CONSOLIDATION OF EVERY 10 EXISTING ORDINARY SHARES IN DGB ASIA BERHAD ("DGB" OR THE "COMPANY") ("DGB SHARES" OR "SHARES") HELD AT 5.00 P.M. ON 24 NOVEMBER 2020 INTO 1 SHARE ("CONSOLIDATED SHARE") ("SHARE CONSOLIDATION").

In relation to the Share Consolidation undertaken by **DGB** as a SPEEDS Corporate Exercise, Bursa Malaysia Securities Berhad would like to highlight that:

- (a) on or after the Ex-date on 23 November 2020, trading of **DGB** shares will be based on the newly adjusted shares after the Share Consolidation of **DGB** shares,
- (b) on the basis of settlement taking place after 24 November 2020 with consolidated **DGB** shares, any entitled shareholder who owns **DGB** shares as at Ex-date may sell only up to the maximum **DGB** shares he expects to receive after the Share Consolidation, i.e. the reduced amount, on or after the Ex-date 23 November 2020.

With the adjustments pursuant to the Share Consolidation effected on **DGB** shareholders' CDS account at the end of the Entitlement Date ("Books Closure Date"), an entitled **DGB** shareholder may use the following basis to estimate the maximum number of **DGB** shares that he may sell from the Ex-date until the Book Closing Date which is from 23 November 2020 until 24 November 2020.

Illustration:

For example, if Mr X owns or purchases **1000** DGB shares on cum basis on 20 November 2020, his CDS account would still show **1000** DGB shares until 24 November 2020. However, as a results of the above Share Consolidation exercise, Mr X's **1000** DGB shares in his CDS account will be adjusted to **100** DGB shares on the night of 24 November 2020 which is the Book Closing Date. Therefore, Mr X may, if he so wishes, sells only up to **100** DGB shares on or after the Ex-date i.e. from 23 November 2020 onwards.

Participating Organisations are hereby requested to caution all dealers and remisiers that, during the period from 23 November 2020 until 24 November 2020, they are only entitled to sell the maximum of 1/10 of the shares owned before the Ex-date. Participants Organisations are reminded that it is important to caution all dealers and remisiers on the above to prevent the dealers and remisiers from overselling of their client's position.
