IMPOSITION OF SERVICE TAX PURSUANT TO THE SERVICE TAX (AMENDMENT) REGULATIONS 2025

1.0 INTRODUCTION

1.1 Pursuant to the Service Tax (Amendment) Regulations 2025, provision of financial services is subject to 8% service tax effective 1 July 2025.

2.0 IMPOSITION OF SERVICE TAX

- 2.1 Bursa Malaysia Securities Berhad ("Bursa Securities") will charge 8% service tax on the following fees pursuant to Rule 3.07 under the Rules of Bursa Securities :
 - (a) Application fee
 - (b) Registration fee
 - (c) Annual subscription fee
- 2.2 In relation to fees for services provided spanning before and after 1 July 2025, please note that 8% service tax shall be applicable on the proportion of the services from 1 July 2025 to 31 December 2025. However, service tax will not be applicable if the relevant fees are fully paid to Bursa Securities prior to 1 July 2025.
- 2.3 The schedule for market participant related fees has been updated accordingly as attached and is also available at Bursa Malaysia Berhad's website at <u>http://www.bursamalaysia.com/.</u>
- 2.4 The service tax amount will be reflected in the invoice issued by Bursa Securities to each Participating Organisation.

3.0 EFFECTIVE DATE

3.1 8% service tax on the fees stated in paragraph 2 above will be charged effective from 1 July 2025.
