### PRICEWORTH INTERNATIONAL BERHAD ("PWORDH" (7123)) SHARE CONSOLIDATION

Participating Organisations are to take note of the following Share Consolidation exercise by **PRICEWORTH INTERNATIONAL BERHAD**

The Share Consolidation comprises the following:-

**CONSOLIDATION OF EVERY 10 EXISTING ORDINARY SHARES IN PRICEWORTH INTERNATIONAL BERHAD ("PWI" OR THE "COMPANY") ("PWI SHARES" OR "SHARES") HELD AT 5.00 P.M ON 6 SEPTEMBER 2021 INTO 1 PWI SHARE ("CONSOLIDATED SHARE") ("SHARE CONSOLIDATION")**

In relation to the Share Consolidation undertaken by **PWORDH** as a SPEEDS Corporate Exercise, Bursa Malaysia Securities Berhad would like to highlight that:

- on or after the Ex-date on 3 September 2021, trading of **PWORDH** shares will be based on the newly adjusted share after the Share Consolidation of **PWORDH** shares,
- on the basis of settlement taking place after 6 September 2021 with consolidated **PWORDH** shares, any entitled shareholder who owns **PWORDH** shares as at Ex-date may sell only up to the maximum **PWORDH** shares he expects to receive after the Share Consolidation, i.e. the reduced amount, on or after the Ex-date 3 September 2021.

With the adjustments pursuant to the Share Consolidation effected on **PWORDH** shareholders' CDS account at the end of the Entitlement Date ("Books Closure Date"), an entitled **PWORDH** shareholder may use the following basis to estimate the maximum number of **PWORDH** shares that he may sell from the Ex-date until the Book Closing Date which is from 3 September 2021 until 6 September 2021.

<b>Number of PWORDH shares that may be sold from 3 September 2021 until 6 September 2021</b>	=	<b><u>Number of shares held</u> 10</b> <b>(All fractional shares computed should be disregarded)</b>

Illustration:

For example, if Mr X owns or purchases **1000** Pworth shares on cum basis on 2 September 2021, his CDS account would still show **1000** Pworth shares until 6 September 2021. However, as a result of the above Share Consolidation exercise, Mr X's **1000** Pworth shares in his CDS account will be adjusted to **100** Pworth shares on the night of 6 September 2021 which is the Book Closing Date. Therefore, Mr X may, if he so wishes, sell only up to **100** Pworth shares on or after the Ex-date i.e. from 3 September 2021 onwards.

**Participating Organisations are hereby requested to caution all dealers and remisiers that, during the period from 3 September 2021 until 6 September 2021, they are only entitled to sell the maximum of 1/10 of the shares owned before the Ex-date. Participants Organisations are reminded that it is important to caution all dealers and remisiers on the above to prevent the dealers and remisiers from overselling of their client's position.**
