JOE HOLDING BERHAD - WARRANTS B 2021/2024 ("JOE-WB" (7096WB)) ADJUSTMENT TO THE EXERCISE PRICE AND NUMBER OF OUTSTANDING WARRANTS PURSUANT TO SHARE CONSOLIDATION

Participating Organisations are to take note of the following Share Consolidation exercise by JOE HOLDING BERHAD - WARRANTS B 2021/2024

The Share Consolidation comprises the following: -

ADJUSTMENTS TO THE EXERCISE PRICE AND NUMBER OF OUTSTANDING WARRANTS 2021/2024 IN JOE HOLDING BERHAD ("JOE" OR "COMPANY") ("WARRANT(S) B") CONSTITUTED BY THE DEED POLL DATED 8 APRIL 2021 ("DEED POLL B") PURSUANT TO THE CONSOLIDATION OF EVERY 10 EXISTING ORDINARY SHARES IN JOE ("JOE SHARE(S)" OR "SHARE(S)") INTO 1 JOE SHARE HELD AT 5.00 P.M. ON 23 OCTOBER 2023 ("ENTITLEMENT DATE") ("SHARE CONSOLIDATION") ("ADJUSTMENTS")

In relation to the warrants adjustment undertaken by **JOE-WB** as a SPEEDS Corporate Exercise, Bursa Malaysia Securities Berhad would like to highlight that:

- (a) on or after the Ex-date on 20 Oct 2023, trading of **JOE-WB** shares will be based on the newly adjusted warrants arising from warrants adjustments,
- (b) on the basis of settlement taking place after 23 Oct 2023 with adjusted JOE-WB shares, an entitled warrants holder who owns JOE-WB shares as at Ex-date may sell only up to the maximum JOE-WB shares he expects to receive after the adjustment, i.e. the reduced amount, on or after the Ex-date 20 Oct 2023.

With the warrants adjustments pursuant to the Share Consolidation effected on **JOE-WB** shareholders' CDS account at the end of the Entitlement Date ("Books Closure Date"), an entitled **JOE-WB** shareholder may use the following basis to estimate the maximum number of **JOE-WB** shares that he may sell from the Ex-date until the Book Closing Date which is from 20 Oct 2023 until 23 Oct 2023.

Illustration:

For example, if Mr X owns or purchases 1000 **JOE-WB** shares on cum basis on 19 Oct 2023, his CDS account would still show 1000 **JOE-WB** shares until 23 Oct 2023. However, as a result of the above Share Consolidation exercise, Mr X's 1000 **JOE-WB** shares in his CDS account will be adjusted to 100 **JOE-WB** shares on the night of 23 Oct 2023 which is the Book Closing Date. Therefore, Mr X may, if he so wishes, sells only up to 100 **JOE-WB** shares on or after the Ex-date i.e. from 20 Oct 2023 onwards.

Participating Organisations are hereby requested to caution all dealers and remisiers that, during the period from 20 Oct 2023 until 23 Oct 2023, they are only entitled to sell the maximum of 1/10 of the shares owned before the Ex-date. Participants Organisations are reminded that it is important to caution all dealers and remisiers on the above to prevent the dealers and remisiers from overselling of their client's position.
