VIZIONE HOLDINGS BERHAD - WARRANTS 2022 / 2025 ("VIZIONE-WE" (7070WE))
ADJUSTMENT TO THE EXERCISE PRICE AND NUMBER OF OUTSTANDING WARRANTS
PURSUANT TO SHARE CONSOLIDATION

Participating Organisations are to take note of the following Share Consolidation exercise by VIZIONE HOLDINGS BERHAD - WARRANTS 2022 / 2025

The Share Consolidation comprises the following: -

ADJUSTMENTS TO THE EXERCISE PRICE AND NUMBER OF OUTSTANDING WARRANTS 2022/2025 IN VIZIONE HOLDINGS BERHAD ("VIZIONE" OR THE "COMPANY") ("WARRANTS E") AS SPECIFIED IN THE DEED POLL DATED 14 JANUARY 2022 ("DEED POLL E"), PURSUANT TO THE CONSOLIDATION OF EVERY 5 EXISTING ORDINARY SHARES IN VIZIONE ("VIZIONE SHARES" OR "SHARES") INTO 1 VIZIONE SHARE ("CONSOLIDATED SHARE") HELD AT 5.00 P.M. ON 3 OCTOBER 2024 ("ENTITLEMENT DATE") ("SHARE CONSOLIDATION")

In relation to the warrants adjustment undertaken by **VIZIONE-WE** as a SPEEDS Corporate Exercise, Bursa Malaysia Securities Berhad would like to

- (a) on or after the Ex-date on 2 Oct 2024, trading of **VIZIONE-WE** shares will be based on the newly adjusted warrants arising from warrants adjustments,
- (b) on the basis of settlement taking place after 3 Oct 2024 with adjusted **VIZIONE-WE** shares, an entitled warrants holder who owns **VIZIONE-WE** shares as at Ex-date may sell only up to the maximum **VIZIONE-WE** shares he expects to receive after the adjustment, i.e. the reduced amount, on or after the Ex-date 2 Oct 2024.

With the warrants adjustments pursuant to the Share Consolidation effected on **VIZIONE-WE** shareholders' CDS account at the end of the Entitlement Date ("Books Closure Date"), an entitled **VIZIONE-WE** shareholder may use the following basis to estimate the maximum number of **VIZIONE-WE** shares that he may sell from the Ex-date until the Book Closing Date which is from 2 Oct 2024 until 3 Oct 2024.

Number of VIZIONE-WE shares that may be sold from 2 Oct 2024 until 3		Number of shares held 5
Oct 2024		(All fractional shares computed should be disregarded)



Illustration:

For example, if Mr X owns or purchases 500 **VIZIONE-WE** shares on cum basis on 1 Oct 2024, his CDS account would still show 500 **VIZIONE-WE** shares until 3 Oct 2024. However, as a result of the above Share Consolidation exercise, Mr X's 500 **VIZIONE-WE** shares in his CDS account will be adjusted to 100 **VIZIONE-WE** shares on the night of 3 Oct 2024 which is the Book Closing Date. Therefore, Mr X may, if he so wishes, sells only up to 100 **VIZIONE-WE** shares on or after the Exdate i.e. from 2 Oct 2024 onwards.

Participating Organisations are hereby requested to caution all dealers and remisiers that, during the period from 2 Oct 2024 until 3 Oct 2024, they are only entitled to sell the maximum of 1/5 of the shares owned before the Ex-date. Participating Organisations are reminded that it is important to caution all dealers and remisiers on the above to prevent the dealers and remisiers from overselling of their client's position.
