IMPIANA HOTELS BERHAD ("IMPIANA" (7243)) SHARE CONSOLIDATION

Participating Organisations are to take note of the following Share Consolidation exercise by **IMPIANA HOTELS BERHAD**.

The Share Consolidation comprises the following :-

CONSOLIDATION OF EVERY 5 EXISTING ORDINARY SHARES IN IMPIANA HOTELS BERHAD ("IMPIANA" OR THE "COMPANY") ("IMPIANA SHARES" OR "SHARES") HELD AT 5.00 P.M ON 7 DECEMBER 2022 INTO 1 NEW IMPIANA SHARE ("CONSOLIDATED SHARE") ("SHARE CONSOLIDATION").

In relation to the Share Consolidation undertaken by **IMPIANA** as a SPEEDS Corporate Exercise, Bursa Malaysia Securities Berhad would like to highlight that:

- (a) on or after the Ex-date on 6 Dec 2022, trading of **IMPIANA** shares will be based on the newly adjusted shares after the Share Consolidation of **IMPIANA** shares,
- (b) on the basis of settlement taking place after 7 Dec 2022 with consolidated **IMPIANA** shares, any entitled shareholder who owns **IMPIANA** shares as at Ex-date may sell only up to the maximum **IMPIANA** shares he expects to receive after the Share Consolidation, i.e. the reduced amount, on or after the Ex-date 6 Dec 2022.

With the adjustments pursuant to the Share Consolidation effected on **IMPIANA** shareholders' CDS account at the end of the Entitlement Date ("Books Closure Date"), an entitled **IMPIANA** shareholder may use the following basis to estimate the maximum number of **IMPIANA** shares that he may sell from the Ex-date until the Book Closing Date which is from 6 Dec 2022 until 7 Dec 2022.

Number of IMPIANA shares that may be sold from 6 Dec 2022 until 7 Dec 2022	=	<p style="text-align: center;"><u>Number of shares held</u> 5</p> <p>(All fractional shares computed should be disregarded)</p>

Illustration:

For example, if Mr X owns or purchases **1000 IMPIANA** shares on cum basis on 5 Dec 2022, his CDS account would still show **1000 IMPIANA** shares until 7 Dec 2022. However, as a result of the above Share Consolidation exercise, Mr X's **1000 IMPIANA** shares in his CDS account will be adjusted to **200 IMPIANA** shares on the night of 7 Dec 2022 which is the Book Closing Date. Therefore, Mr X may, if he so wishes, sell only up to **200 IMPIANA** shares on or after the Ex-date i.e. from 6 Dec 2022 onwards.

Participating Organisations are hereby requested to caution all dealers and remisiers that, during the period from 6 Dec 2022 until 7 Dec 2022, they are only entitled to sell the maximum of 1/5 of the shares owned before the Ex-date. Participants Organisations are reminded that it is important to caution all dealers and remisiers on the above to prevent the dealers and remisiers from overselling of their client's position.
